## STATEMENT OF REASONS

The facility is located in a detached building. The area of the facility is 140.00 m<sup>2</sup>, height of premises ranges from 3.00 m to 6.80 m. It is made of warehouse hall, sanitary and social premises and office premises. The surfaces are smooth, easy to be cleaned. The facility has the access to water and sewage network. Mechanical ventilation is ensured in the hall, and gravitational ventilation in the remaining premises. The conditions to wash the hands are ensured. The result of water testing was produced – Report from the tests No 626/S/HK/08 of 9<sup>th</sup> June 2008, confirming the fulfillment of the requirements of water quality designated for drinking purposes.

The facility fulfills hygienic and sanitary requirements pursuant to Art. 59 of the 25<sup>th</sup> August 2006 Act on the Safety of Food and Nutrition (Journal of Laws of 2019 item 1252 as amended).

Considering the above, the State District Sanitary Inspector in Toruń approves the above described food warehouse at 13 Towarowa Street in Toruń (warehouse C), belonging to Mr. Tomasz Franków, the owner of 4Life Pharma Tomasz Franków company with its seat at 2 flat 6 Jurija Gagarina Street in Toruń.

## INSTRUCTIONS

The party may appeal from this decision to the State Regional Sanitary Inspector in Bydgoszcz, through the intermediary of the State District Sanitary Inspector in Toruń, 1 Szosa Bydgoska Street, 87-100 Toruń, within 14 days from having received the decision; the party has also the right to renounce the right to appeal. In accordance with Art. 127a of the 14<sup>th</sup> June 1960 Act – Code of Administrative Procedure the party may, during the above mentioned period of 14 days to submit the appeal, file, with the State District Sanitary Inspector declaration on renouncing the right to appeal. The decision becomes final and valid with the day the body receives the declaration on renouncing the right to appeal by the last of the parties to the proceedings. Such decision cannot be appealed from to the Provincial Administrative Court.
